

**NOTICE OF PUBLIC HEARING
INCORPORATED VILLAGE OF MUTTONTOWN**

NOTICE IS HEREBY GIVEN, that the Board of Trustees of the Incorporated Village of Muttontown will hold a public hearing commencing at 7:05pm on Wednesday November 10, 2021, at Village Hall, One ‘Raz’ Tafuro Way, Muttontown, NY 11791 with respect to the matter summarized below:

**PROPOSED LOCAL LAW 5 OF 2021 PURSUANT TO CANNABIS LAW
SECTION 131 OPTING OUT OF LICENSING AND ESTABLISHING RETAIL
CANNABIS DISPENSARIES AND/OR ON-SITE CANNABIS CONSUMPTION
ESTABLISHMENTS WITHIN THE INCORPORATED VILLAGE OF MUTTONTOWN**

Section 1. Legislative Intent

It is the intent of this local law to opt the Incorporated Village of Muttontown out of having retail cannabis dispensaries and/or on-site cannabis consumption establishments within its municipal boundaries.

Section 2. Authority

This local law is adopted pursuant to Cannabis Law Section 131, which expressly authorized Villages to opt-out of allowing retail cannabis dispensaries and/or on-site cannabis consumption establishments to locate and operate within its municipal boundaries.

Section 3. Local Cannabis Retail Dispensary and/or On-Site Consumption Opt-Out

The Board of Trustees of the Incorporated Village of Muttontown hereby opts out of allowing retail cannabis dispensaries and/or on-site cannabis consumption establishments from locating and operating within its municipal boundaries.

Section 4. Severability

If a court determines, that any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court’s order or judgment shall not affect, impair or invalidate the remainder of this local law, but shall be confined to its operation to the clause, sentence, paragraph, subdivision or part of this local law or in its application to the person, individual firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date

This Local law shall take effect immediately. Pursuant to Cannabis Law Section 131, this local law is subject to a permissive referendum and thus may not be filed with the secretary of state until the applicable time period has elapsed to file a petition or a referendum has been conducting approving this local law.
