#### **Departmental Reports**

Trustee Economou gave a report on the Muttontown Police Department and asked Sergeant Wallace to give the report for the month of August 2023.

Mayor Liguori asked Acting Clerk Joe Russo to give a treasurer's report for the month ending August 2023. Acting Clerk Russo discussed the bank reconciliation data from village statements ending July 31, 2023 through statement end date August 30, 2023.

**Resolution 23-113** – A motion was made by Trustee Fagen and seconded by Trustee Schloss and carried unanimously to approve the return of escrow accounts A-T204-6 and A-T204-3 to 2062 Crest LLC.

**Resolution 23-114** – A motion was made by Deputy Mayor Prasad and seconded by Trustee Fagen and carried unanimously to approve the warrants which will be audited by a majority of the Board of Trustees before payment is made, and are hereby offered for approval by the Board of Trustees and authorize the Clerk/Treasurer to process said payments.
