Resolution 26-20 – A motion was made by Trustee Fagen and seconded by Deputy Mayor Prasad and carried unanimously to approve the proposal by Municipal Valuation Services Inc for Village Assessment, Certiorari Services and small claims for June 1, 2026 - May 31, 2027 dated February 4th 2026.
